August 13, 2018 – Agenda Planning Meeting

1. A service agreement with Step By Step Learning was approved for St. Sylvester School.
2. The Board approved amended transportation contracts for the 2018-2019 school year.
3. The sports officials and game crew rates for 2018-2019 were approved.
