April 12 & 19, 2021

The information listed below is a *summary* of action taken at the April 12, 2021 Agenda Planning Meeting and the April 19, 2021 General Purpose Meeting. The official minutes of these meetings should be consulted if more detail is sought on any item.

April 12, 2021 – Agenda Planning Meeting

1. The Board ratified the updated Brentwood Borough School District Health and Safety Plan.

April 19, 2021 – General Purpose Meeting

1. The minutes from the March 8, 2021 Agenda Planning Meeting and the March 15, 2021 General Purpose Meeting were approved.
2. The Board approved the Statement of Cash Receipts, Disbursements, and Cash Balances for the period ending March 31, 2021; approved bill payments for the period March 16 thru April 19, 2021; and approved budget transfers for the month of April 2021. In addition, the Board acknowledged receipt of the bank letter.
3. The Board approved hiring up to three interns to assist the technology department.
5. Mr. Scott Gindlesperger was hired as a Maintenance/Custodian Assistant, pending receipt of all the appropriate paperwork.
6. The Board approved additions to the substitute list.
7. The Board ratified extending Mrs. Sue Milius' leave of absence effective April 1, 2021 through June 10, 2021.
8. Mrs. Kristie Thieshen's resignation for the purpose of retirement was accepted, with regret, effective the last teacher day of the 2020-2021 school year.
9. A leave of absence for Mrs. Katie Rodriguez was ratified, effective April 6, 2021.
10. The 2021-2022 school calendar was approved.
11. A participation agreement with PSBA for the Policy Maintenance Program and Administrative Regulation Services was approved.
12. The Board approved purchasing Lot/Block 188-F-125 (54 W. Willock Road) per an agreement of sale, for potential future school development uses.
13. The Board approved the District's participation in a pilot program being offered through the Allegheny County Health Department (ACHD) and the state of Pennsylvania to test students and staff members for COVID-19 using rapid antigen testing.
14. The Board approved the biennial band, chorus and school musical trip to Florida in March 2022. Approval will be pending COVID-19 restrictions, travel advisories, and the availability of the parks in 2022. The Administration understands and will take into consideration any health and safety issues that may arise prior to the trip.
15. Dr. Christine Winiarski was named the Title IX Coordinator for the District, effective immediately.
