

# School District of Borough of Brentwood

## April 11 & 25, 2022

The information listed below is a *summary* of action taken at the April 11, 2022 Agenda Planning Meeting and the April 25, 2022 General Purpose Meeting. The official minutes of these meetings should be consulted if more detail is sought on any item.

### April 11, 2022 – Agenda Planning Meeting

- Mrs. Stephanie DeLuca presented a second math program to be piloted this spring.
  1. The Board approved the pilot of the Illustrative Math resource for the spring of 2022 in the one math classroom per grade level at the elementary schools.
  2. The Board approved the addition to the custodian substitute list.
  3. The Board hired Natalie Andrews as a Paraprofessional.
  4. The Board tabled the motion to ratify Mr. Paul Schaap to serve as the sound engineer for the high school musical.
  5. The Board ratified the hiring of Mr. Bryan Sable as the musical director for the high school musical for the 2021-2022 school year.
- Representative Jessica Benham joined the meeting via Zoom to discuss educational funding.
- Director Bogdanski presented the most recent report on the safety and security updates for the 2021-2022 school year (Presentation done in Executive Session).
- Informational- The updated Special Education Plan was provided on the district's website on April 6 for a required 28-day review cycle.

### April 25, 2022 – General Purpose Meeting

1. The minutes from the March 14, 2022 Agenda Planning Meeting and the March 21, 2022 General Purpose Meeting were approved.
2. The Board approved the Statement of Cash Receipts, Disbursements, and Cash Balances for the period ending March 31, 2022; approved bill payments for the period March 22 thru April 25, 2022; and the Board acknowledged receipt of the bank letter.
3. The Board approved teacher/adult chaperones and student counselors for Camp Kon-O-Kwee 2012 (May 4-6, 2022). The Superintendent was given authorization to hire additional Camp Kon-O-Kwee counselors and chaperones as needed with ratification at the May Board meeting.
4. A Memorandum of Understanding between the District and the BEA to split the Camp Kon-O-Kwee director position for the 2021-2022 school year was approved.
5. The Board approved HHS DR to obtain a metes and boundary survey to include the 52 and 54 West Willock Road for school construction plans.
6. The Board approved the purchasing of Dell Chromebooks, licenses, extended warranty, and cases.
7. The Board approved the posting of the following positions: one full-time school police officer, and one elementary principal position.
8. Mrs. Kayla Hubsch's resignation as the high school head volleyball coach and authorized the Superintendent to post this position.
9. The Board approved FMLA leave for Mrs. Whitney Reynolds, effective April 2, 2022.
