The information listed below is a *summary* of action taken at the December 4, 2023 Organization and Agenda Planning Meetings and the December 11, 2023 General Purpose Meeting. The official minutes of these meetings should be consulted if more detail is sought on any item.

December 4, 2023 - Organization Meeting and Agenda Planning Meeting

- 1. The newly re-elected directors (Mr. Richard Briner, Mr. Robert Kircher, Jr., and Mr. David Schaap) and the newly elected director (Mrs. Jennifer George) were sworn in by Michelle Fusco, Notary Public, and the Certificates of Election and Oaths of Office were presented to the Board Secretary.
- 2. After the Notice of Organization Meeting was read (as per the Sunshine Law) officers were elected for 2024 as follows:

Mr. Richard Briner Vice President

Mr. Gary Topolosky Assistant Secretary (no change)

Mrs. Donna Werner continues to be the Secretary for the Board.

- 3. The Board voted to retain Tucker Arensberg as the school solicitor and collector of delinquent property taxes for 2024, retained First National Bank as the school district's designated depository, authorized the district utilize PSDLAF as a depository and serve as an investment vehicle for district funds, and approved the Pittsburgh Post-Gazette and the South Hills Monthly for advertising.
- 4. The Board accepted, with regret, Mr. David Tinker's resignation from the School Board of Directors, effective December 4, 2023.
- Mrs. Jennifer Pesanka gave a bond pricing presentation.

December 11, 2023 – General Purpose Meeting

- 1. Ms. Antonia Focer-Brown was appointed to the School District Board of Directors, effective immediately after taking the Oath of Office.
- 2. The minutes from the November 13, 2023 Agenda Planning Meeting, and the November 20, 2023 General Purpose Meeting were approved.
- 3. The Board approved the General Fund 10 Statement of Cash Receipts, Disbursements, and Cash Balances for the periods ending November 30, 2023; approved the bill payments for the period November 21 thru December 11, 2023. The Board also acknowledged receipt of the bank letter.
- 4. A resolution stating that the district will not raise property taxes by more than the adjusted index of 7.5% for 2024-2025 was approved. With this resolution, the school district foregoes the preliminary budget process and is instead only subject to the traditional May proposed budget timeline.
- 5. The Board approved budget transfers resulting from the local independent audit reclassifications subsequent to June 30, 2023, as determined by the Annual Financial Report.
- 6. The Board awarded the Demolition Construction New Elementary School bid to Tamco Construction, Inc.
- 7. The updated job description for the Athletic/Activities Director was approved.
- 8. FMLA leave was approved for Mrs. Michelle Fusco.
- 9. Mr. Roger Gaughan was hired as the athletic and activities director effective January 2, 2024.
