## July 15, 2024

The information listed below is a *summary* of action taken at the July 15, 2024 Combined Agenda Planning / General Purpose Meeting. The official minutes of these meetings should be consulted if more detail is sought on any item.

### July 15, 2024 – General Purpose Meeting

1. The minutes from the June 10, 2024 Agenda Planning Meeting and the June 17, 2024 General Purpose Meeting were approved.
2. The General Fund 10, the Statement of Cash Receipts, Disbursements and Cash Balances for the period ending June 30, 2024 were approved; and approved bill payments for the period June 28 thru July 15, 2024. In addition, the Board acknowledged receipt of the bank letter.
3. The following revised policies were adopted after the second and final reading:

5. The Board approved the superintendent to approve transportation for the 2024-2025 school year, as needed.
6. A girls' varsity and junior varsity soccer co-op agreement between the Brentwood Borough School District and the Baldwin Whitehall School District was approved.
7. Mr. Kevin Patterson, Mr. Dan Golvash, and Mrs. Dawn Ziegler were hired as the Middle School Girls Basketball coaches.
8. Admission fees for the 2024-2025 school year were approved as follows:

12. The Board approved the ratified agreement with Kroll Associates Inc., Mullen Coughlin, LLC and the District for Information Security Services.
13. A 4% increase for confidential and at will employees for the 2024-2025 school year as follows: Mrs. Michelle Fusco, Mrs. Kristin Alex, Mr. Rick Huffman.
