The information listed below is a *summary* of action taken at the March 9, 2020 Agenda Planning Meeting and the March 16, 2020 General Purpose Meeting. The official minutes of the meeting should be consulted if more detail is sought on any item.

March 9, 2020 – Agenda Planning Meeting

1. The District postage machine lease was extended with The Wilson Group.
2. A transportation run and the bus driver for one student was ratified with First Student.
3. The 2019-2020 revised calendar was approved (the only change was a change in the date for the primary election from April 21 to April 28, 2020).
4. Homebound instruction for a high school student was ratified.

March 16, 2020 – General Purpose Meeting

1. The minutes from the February 10, 2020 Agenda Planning Meeting and the February 24, 2020 General Purpose Meeting were approved.
2. The Board approved the Statement of Cash Receipts for the period ending Feb. 29, 2020, authorized bill payments for the period Feb. 25 thru March 16, 2020, and authorized the Business Manager to pay bills in March and April 2020 with ratification at the next Board meeting. The Board acknowledged receipt of the bank letter.
3. The School District Financial Statements and Independent Auditor's Report for the year ending June 30, 2019 was approved, as prepared by Bielau, Tierney, Coon and Company.
4. Mrs. Sherry Nystrom's resignation, for the purpose of retirement, was accepted, with regret, effective the last teacher day of the 2019-2020 school year.
5. Mr. Michael Spanos was hired for the part-time physical education teaching position, effective March 19, 2020.
6. Mr. Ryan Eperthener was hired as a part-time security officer, pending receipt of all the appropriate paperwork and completion of NASRO Basic Training.
7. Mr. Nicholas Balkovec was hired as a part-time security officer, pending receipt of all the appropriate paperwork and completion of NASRO Basic Training.
8. The Board approved Mr. Ryan Fahrner's request to transfer to the maintenance/custodian assistant position and authorized the Superintendent to post a custodial position.
