The information listed below is a *summary* of action taken at the November 9, 2020 Agenda Planning Meeting and the November 16, 2020 General Purpose Meeting. The official minutes of these meetings should be consulted if more detail is sought on any item.

November 9, 2020 – Agenda Planning Meeting

1. The Board rejected the separate prime bids for HVAC and electrical construction for the Cafeteria and Auditorium HVAC equipment replacement and authorized HHS DR to prepare new bid documents and authorized the Superintendent to advertise for new bids.
2. A transportation run with PA Coach for one student to Pittsburgh Pioneer was approved.
3. Mrs. Lindsay Klousnitzer's resignation was accepted, effective October 31, 2020 and the Superintendent was authorized to post this position in the spring of 2021.
4. Mrs. Whitney Reynolds resigned as the middle school cheerleading head coach and the Superintendent was authorized to post this position.
5. Mr. John Bick was hired as an evening custodian, effective November 10, 2020.
6. Mrs. Carrie Hackett was hired as a long-term sub for the remainder of the 2020-2021 school year, effective November 16, 2020.

November 16, 2020 – General Purpose Meeting

1. The minutes from the October 12, 2020 Agenda Planning Meeting and the October 19, 2020 General Purpose Meeting were approved.
2. The Board approved the Statement of Cash Receipts, Disbursements and Cash Balances for the period ending October 31, 2020, authorized bill payments for the period Oct. 20 thru Nov. 16, 2020, and acknowledged receipt of the bank letter and the tax collector's report.

10. A Memorandum of Understanding between the Allegheny Intermediate Unit and the District for translation services was approved for the period February 10, 2021 through February 10, 2022.
11. The Board approved extending the application deadline for the Early Retirement MOU with the BEA from December 1st to February 1, 2021.
